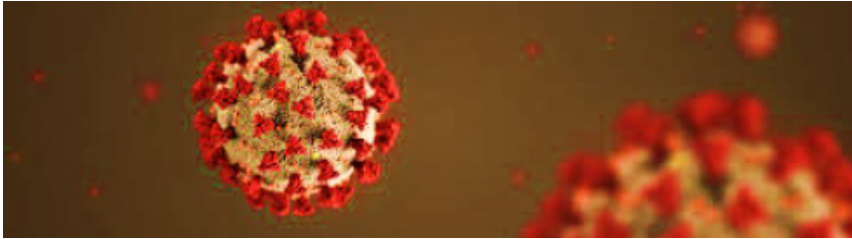

Early investment by a local DFW manufacturer in cutting edge electrostatic application technology, proven during the 2014 Ebola outbreak, enables FPC to offer mitigation services. Utilizing an electrostatic dispersion system that pressurizes and atomizes a sodium dichloro-s-triainetriane (NaDCC) solution. Current demand limits availability; however, FPC has been able to reserve quantities available to serve our customers with projected growth opportunity.

Contact a Business Developer to determine the appropriate level of treatment from Preventative Measure, Potential Exposure or Confirmed Exposure. One-time emergency treatments may be available (schedule permitting). The recommended frequency for application is weekly. Bi-weekly and monthly treatment plans are available.

Application and treatment can occur either during or after business hours\*. If your office has been temporarily closed either because of a business decision or the result of judicial order, FPC can pre-treat and eliminate any potential scheduling conflicts upon your return. This enables your workforce to return to work sooner than might otherwise be permitted while giving your staff the assurance of a safe working environment.

*\*We recommend "level 3 – Confirmed Exposure" treatments be conducted without staff present due to the intensive treatment process and the required use of personal protective equipment.*
